# RESEARCH REPORT for WARREN CULPEPPER March 11, 2012

#### By Diane Rapaport

## **Research Objectives**

In this fourth phase of our research project, I continued seeking historical records about people named Culpepper, Culpeper, Colepeper (and similar spelling variants) in colonial New England, following up on the work and recommendations set forth in my research report of January 9, 2012 (and the earlier reports of September 7 and October 13, 2011).

# **Summary of Research Results**

I worked onsite at several repositories, including the New England Historic Genealogical Society, the Boston Public Library Rare Books and Manuscripts Department, and the American Antiquarian Society, and I corresponded with a reference librarian at the Massachusetts Historical Society, who conducted some research for me in collection indexes there. And I accessed many other records and sources online. Full details are set forth in my "Research Notes" below, and I am emailing copies of the documents and records cited in this report as JPG and PDF files.

Despite my extensive research, I found only a few items of potential interest in this phase of the project, some perhaps adding further information that you do not already know about the Culpepers, but other materials appearing to be duplicative of documentation found previously. To summarize:

# John Culpeper of Albemarle

You asked me to review entries in Vol. 10 of the *Calendar of State Papers, Colonial Series* (found in the index during the previous research) about John Culpeper, which I did, and I also found brief entries about John and the rebellion in *Acts of the Privy Council of England, Colonial Series, Vol. I, 1613-1680*. See my "Research Notes" below and copies of the relevant pages, which I do not believe add much to the information you already had.

In my search for other sources mentioning John Culpeper, I discovered that Harvard University has materials of possible interest, which I did not have time to review, including eight pages titled "Culpeper, John, Report of elections...of N.Car...," at the Harvard Law School (cataloged as "Rare Trials") from Readex microform. Harvard's Pusey Library map collection also has photocopies of North Carolina maps drawn by John Culpeper in 1671 and 1672, from the British Public Record Office. Probably these maps are the same as referred to in Volume 7 of the *Calendar of State Papers*, from the Shaftesbury Papers; see pp. 9-10 of my research report of January 9, 2012.

## **Colonel Alexander Culpeper**

You also asked me to check entries in Vol. 10 of the *Calendar of State Papers, Colonial Series* (found in the index during the previous research) about Colonel Alexander Culpeper. (You often have seen Alexander, Surveyor General of Virginia, referred to as "Captain," but never as "Colonel.")

These records, although all indexed as "Colonel" Alexander Culpeper, referred to him in some cases as "Mr." Culpeper or simply as Alexander Culpeper, not always as "Colonel." He was identified as the administrator of the estate of Sir William Berkeley. See my "Research Notes" below and copies of the relevant pages.

# **Culpepers Involved With East India Company**

You had expressed interest, in connection with research in the *Calendar of State Papers*, *Colonial Series*, about a branch of the Colepepers/Culpepers involved with the British East India Company, including Edmund Culpeper of India (b. abt. 1728, relocated to Madras, Tamil Nadu, India abt. 1750, m. Sarah abt. 1755 or Joanna abt. 1757, son Charles, b. abt. 1758 – described more fully at <a href="http://gen.culpepper.com/ss/p61313.htm">http://gen.culpepper.com/ss/p61313.htm</a>). I found only a few volumes of the *Calendar of State Papers*, *Colonial Series*, covering the East Indies before 1635; it appears that the series did not continue for later years in the 1600s or into the 1700s. In those early volumes, however, I found mention of a **Thomas Culpeper** and **William Culpeper**, London merchants apparently involved in 1612 in a company searching for the Northwest passage. I also found a William Culpepper in the 1624 court minutes of the East India Company. See the "Calendar of State Papers" notes below.

I searched briefly for other sources of records about the East India Company for the time period of interest, and I learned that the British Library in London has extensive records. See "India Office Records and Private Papers" in my "Research Notes" below for further details, at the British Library website. While most of those records appear to be available only for research in London, the website did allow some online searching, and I located a citation about the baptism of an **Edmund Culpepper**, 13 Feb 1779, in Madras, with the notation that his father's name was Charles, and that Edmund was illegitimate. See below for information about ordering a copy of the record, if of interest.

# **Lord Thomas Culpeper**

Lord Thomas Culpeper was not a focus of my research, but I nevertheless continued to run across references to him in various sources, as indicated in my "Research Notes" below. I understand that you already have much information about him, and that you are aware of his interest in land speculation in the colonies. I did, however, copy a few references that might possibly include new details about Lord Thomas Culpeper, particularly his role as agent and one of the largest shareholders of the Atherton

Company (with Massachusetts men such as Gov. Simon Bradstreet, Richard Smith, Francis Brimley, Wait Winthrop and Richard Wharton), which had purchased the "Narragansett lands" from the Indians. That property, as you may be aware, was claimed by both Connecticut and Rhode Island, and it may be of interest since you are trying to track connections re: Culpeper sisters of Branford, Connecticut, and the Culpeper House in Newport, Rhode Island. Possibly Lord Thomas Culpeper conveyed Connecticut or Rhode Island property to other Culpeper relatives. See my "Research Notes" below in the sections re: "Collections at New England Research Repositories," "Miscellaneous" and "Journals."

#### **Recommendations**

In the time available for this project, I was not able to search all repositories that might have documentation about the Culpepers. You might want to consider having me follow up on the records about John Culpeper that I found at Harvard University. I also did not review further volumes of the *Calendar of State Papers* after 1700, which may be of interest. Researching some of the remaining collections that I have identified—at the Massachusetts Archives, the Massachusetts Historical Society or the Boston Public Library, for example—could be very time-consuming, with an uncertain likelihood of finding relevant records. There also may be other archival collections at area universities and libraries, but I did not have time to continue surveying those sources. (I focused primarily on Massachusetts repositories, but there are repositories in other New England states that may be of interest, as well.) I would, however, be happy to continue the search.

In addition, since it appears that Lord Thomas Culpeper owned a good deal of land in New England through the Atherton Company acquisitions, you may want to consider further land research, particularly in Connecticut and Rhode Island, if you have not already done so. I often do research on-site at repositories such as the Rhode Island State Archives and the Connecticut State Library/Archives, if you would like further follow up.

#### CALENDAR OF STATE PAPERS, COLONIAL SERIES

The Calendar of State Papers includes abstracts of manuscripts from the Public Record Office in England.

Volumes 2-4, 6, 8 relate to the East Indies. I searched for Colepepers/Culpepers involved with the British East India Company:

Culpeper**" (p. 239, middle of second column) and "**Wm. Culpeper**" (p. 240, upper third of third column) among people included in "a body corporate and politic by the name of the 'Governor and Company of the Merchants of London, discoverers of the North-west passage." Culpepper** having sent over from Danzig for the Company 190 barrells of gunpowder and 25 'fatts' of salpetre; ordered that the Council of War be petitioned for leave to Mr. Evelyn to make the saltpeter into powder for the Company's use." Note: List of the East Indies series at <u>www.tannerritchie.com</u> suggests that this is the last volume (so apparently none available for the 1700s).

I continued with further research about John Culpeper and Colonel Alexander Culpeper that you requested, in Vol. 10. (See research notes from previous phase of our project in blue, below.)

pp. 662-663 – Many index entries about Lord Thomas Culpeper and **John Culpeper** (of Carolina). *Note: Numbers in index refer to item numbers, not page numbers.* (See copy, **CalStatePapers Col v10p662.jpg** and **CalStatePapers Col v10p663.jpg**.) *Most of the later entries re: John Culpeper appear to relate to his role in the rebellion in Carolina, but the earlier documents show how his involvement in New England trade contributed to that controversy, e.g.:* 

pp. 372-373 (#1017) – 10 Jun 1679 letter from Robert Holden, at Boston, to the Commissioners of Customs, alleging that "Mr. Culpeper" and others colluded to monopolize tobacco trade between Albemarle County and New England. "About half-adozen traders of this place [New England] with their complices receive the greatest part of the production of tobacco in Albemarle county, and by a person whom . . . they have factiously made one Collector of Customs, one Mr. Culpeper; by which means they and he have played such notorious pranks that a people and Customs' treasure were never more . . . cheated . . . . ." p. 460 (#1236) – 19 Dec 1679 order of the King: "For the arrest of **John Culpeper** for assuming the title of Collector of His Majesty's Customs in Carolina, and other proceedings in a rebellion contrived by him and Richard Forster." (See copy, **CalStatePapers Col v10p460.jpg.**)

In addition to the entries about John Culpeper that I reviewed in the last phase of our project (see notes in blue, above), I also searched other entries in the index for John Culpeper:

p. 462 (#1246) – Dec (?) 1679. Abstract of "Representation to the Lords Proprietors of Carolina concerning the rebellion. . . ." Cites collection of 8-1/2 pages, stating that **John Culpeper** and others "took an active part in the rebellion." Papers were "To be made use of in further examinations [of **John Culpeper**?]" (See copy, **CalStatePapers Colv10p462.jpg**.)

p. 473 (#1271) – 16 Jan 1680. Abstract of "Petition of **John Culpeper** to the King in Council. That upon a complaint of Thomas Miller, and by order of the King in Council, he has been in custody of a messenger upwards of 20 days. Prays for his discharge, or

that Miller may give security for the payment of the petitioner's charges if proved innocent." (See copy, **CalStatePapers Col v10p473.jpg**.)

p. 474 (#1274) – 19 Jan 1680. Abstract of "Petition of Thomas Miller to the Commissioners of the Treasury. Petitioner was appointed Collector of Customs in Albemarle County, Carolina, in 1677, and arrived there in July 1677, but in December following was seized, robbed of all his books and papers, and put in irons by the rebels under **John Culpeper** and Zachary Gilham." (Etc.)

pp. 474-475 (#1278) – 22 Jan 1680 papers also mention **John Culpeper**. (See copy, **CalStatePapers Col v10p474.jpg** and **CalStatePapers Col v10p475.jpg**)

p. 477 (#1285) – 4 Feb 1680, Whitehall. Order of the King referring to "examination of seditious practices lately carried on in Carolina by **John Culpeper** and others," scheduled for 8 Feb.

pp. 477-478 (#1288) – 7 Feb 1680. Abstract of "Journal of Lords of Trade and Plantations. In pursuance of the enquiry into the business of the late rebellion in Carolina, the Earls of Shaftesbury and Craven, and Sir Peter Colleton were called in... and then narrated..." Stated that "Mr. Durant, Captains Gilham and **Culpeper** agreed together to defraud the King of his Customs." Sir Richard Temple said "**Culpeper** had no authority to seize the King's Customs," but Culpeper said he was appointed by a lawful Carolina assembly. *Other evidence by and against Culpeper summarized*. p. 478 (#1289) – 7 Feb 1680, Whitehall. Abstract of "Report of Lords of Trade and Plantations to the King," stating they were "satisfied" that **John Culpeper** "aided and abetted a rebellion in Carolina, . . . and that he proclaimed himself collector. **Culpeper** confesses and prays for pardon."

pp. 478-479 (#1290) – 7 Feb 1690. Abstracts of "Papers concerning the rebellion in Carolina read before the Committee of Trade and Plantations in the trial of **John Culpeper**."

pp. 479-480 (#1292) – 8 Feb 1680. Abstract of letter from "Sir P. Colleton to Mr. Blathwayt," with "narrative of the proceedings at Albemarle" and case involving **Culpeper**.

p. 556 (#1411) – 29 Jun 1680, read in Council 30 Jun 1680 and 20 Nov 1680. Abstract of "Petition of Thomas Miller to the King" re: "rebellion in Albemarle County, Carolina, his imprisonment and escape to England, the interference of the Earl of Shaftesbury in favour of **John Culpeper**, a notorious ringleader, who was proved guilty." pp. 590-591 (#1490) – Aug(?) 1680, read 20 Nov 1680. Abstract of 3 pages signed by Craven, Shaftesbury and P. Colleton, "Lords Proprietors of Carolina to Lords of Trade and Plantations," summarizing events in Albemarle County from 1677-1680, mentioning that "the people" of Carolina "set up **John Culpeper**" in the place of Thomas Miller. p. 138 (#374) – Probably 1677. Abstract of "Petition of Alexander Culpeper, Administrator of the estate of Sir William Berkeley, late Governor of Virginia, to the King." (See copy, CalStatePapers Col v10p138.jpg.) pp. 178-179 (#483) - 19 Nov 1677 Abstract of "Certificate of John Lord Berkeley. That he employed **Mr. Culpeper** to view the Virginia Papers and to take copies of such as most concerned his deceased brother which Berkeley desires he may continue to do." (See copy, CalStatePapers Col v10p178.jpg and CalStatePapers Col v10p179.jpg.) pp. 186-187 (#505) – 4 Dec 1677, Whitehall. Abstract of "Journal of Lords of Trade and Plantations. Lord Berkeley moves that the narrative of the late rebellion in Virginia presented by His Majesty's Commissioners be read (see ante, No. 432). Lord Culpeper, the Commissioners, and Colonel Culpeper called in, when said papers are read, and Lord Berkeley presents an answer to the objections against Sir William Berkeley signed by **Colonel Culpeper** which is also read.... Colonel Culpeper's request to alter some expressions in the paper signed by him in justification of Sir William Berkeley not permitted. . . . " p. 187 (#506) – 4 Dec 1677. Apparently part of the text of Colonel Culpeper's "paper" referred to above: "An answer to the objections against Sir William Berkeley in justification of his proceedings. Signed by Alexander Culpeper. The last paragraph is as follows: All these things considered, Sir William Berkeley had great reason to differ from the opinion of the learned Lord Coke..., and to appeal to His Majesty... who it is hoped will find cause to justify Sir William Berkeley's proceedings, which, when the case shall be clearer stated and better understood . . . will be found to have been entirely for the good of the Colony and His Majesty's service though to his own loss and ruin." p. 401 (#1077) – Although index cites #1077 as a "letter" of Colonel Alexander Culpeper, that evidently was error; no mention to Culpeper can be found on this page.

The last volume of the Calendar of State Papers, Colonial Series (America and West Indies) that I reviewed previously was Vol. 12. Thus, in this phase of the project I continued to search that series for entries about Culpeper, Culpeper, Colpeper, Colepeper, etc.:

Since you were interested in finding out more about information about a branch of the Colepepers/Culpepers involved with the British East India Company, including Edmund Culpeper of India (b. abt. 1728, relocated to Madras, Tamil Nadu, India abt. 1750, m. Sarah abt. 1755 or Joanna abt. 1757, son Charles, b. abt. 1758), I made a brief search for resources about the East India Company. As indicated above, the Calendar of State Papers, Colonial Series, re: the East Indies, ended with the volume ending 1634, so I searched for the location of other records.

As previously reported (in my January 9, 2011 report), I searched the online catalog for Culpeper/Culpepper references, as well as papers involving the Lamb family and the town of Roxbury, and other 17<sup>th</sup>-century New Englanders involved in shipping/trading activities of the Culpepers (per records found in previous phases or our research project), including John Winslow, John Stoughton, John Ford, Robert Gibbs, Capt. Edward Wood, Nicholas Page/Paige. I found three collections of possible interest:

Zachariah Chandler, **Zachariah Chandler papers**, **1638-1927**; **bulk**: **1638-1783**. Ms. N-2120. 1 narrow box. Scope: "Legal documents kept by cordwainer Zachariah Chandler of Roxbury (later Boston), Mass., 1638-1783. Includes deeds, quitclaims, and court petitions related to a dispute with Roxbury town selectmen over a highway built on his land. Also includes deeds kept by Chandler family members and other residents of Roxbury. . . . ."

I followed up by email, 2/2/12, with Tracy Potter, Reference Librarian at the MHS, who said that there is no finding aide to the Chandler papers, so I would need to review those records in person at MHS. I did not have time to do so in this phase of the project.

Winthrop Family Papers, 1537-1990; bulk: 1620-1900. Ms N-262; Ms N-263 (Photostats). P-350, 53 reels. See collection guide, MHS Winthrop Family Papers guide.pdf.

Tracy Potter checked the Winthrop "slip-file" on 2/2/12—both the name and date file—but found no results for Culpeper/Culpepper/Colepeper/Colepepper.

**Winslow family papers**, **1690-1887**; **bulk: 1745-1854.** Ms. N-486. 2 boxes. Scope: "Correspondence, diaries, and legal documents of the Winslow and related Pease and Pollard families. . . ."

Per Tracy Potter, the Winslow papers are mostly item indexed in an MHS index called the "manuscript item index," and she searched that index for Culpeper (and name variants), finding no entries. That means there were no documents by the Culpepers in the collection; however, it is possible that documents mentioning the Culpepers might be found with a review of the records. I did not have time to do so.

Tracy Potter also suggested (in a 2/2/12 email) other subject searches in the MHS catalog to consider:

"Subject simple search: "family history," we use this subject phrase to bring together all manuscript collections from families in chronological order. So you can browse all the family collections we have from the 1660s to the 1680s to see if anything relevant pops out at you. I tried a "family history" subject search, but found no additional collections that appeared promising.

Also a Subject advanced search: "Merchants Massachusetts Boston" with a time limit of 1660 to 1680. This will give you an idea of other merchants in the area during this time period." I tried this search, but found no additional collections that appeared promising.

I also searched for the subject "Albemarle" and the name "Robert Holden," the customs collector who reported on John Culpeper and other traders in his 1679 letter in Vol. 10 of the *Colonial State Papers* (see above), but I found no entries that appeared to be relevant.

The *Proceedings*, a series of more than 100 volumes, includes annual reports about historical scholarship of Massachusetts Historical Society members and information from manuscripts. *Note: The "Proceedings" and the "Collections (see below) are two different series from the Massachusetts Historical Society.* 

I reviewed the cumulative indexes, finding several entries to Lord Thomas Culpeper, which I did not take time to record. However, I copied this reference to 1680 visit of Lord Culpeper to Boston, from *Diary of Increase Mather*, since perhaps adds new information:

#### Massachusetts Historical Collections (from 1792–2005)

This series of approximately 100 volumes, mostly transcriptions of manuscript collections at the Massachusetts Historical Society, is partially indexed (not the early

volumes). I reviewed the indexed volumes, but found only references to Lord Thomas Culpeper. I did not take time to record them all, since they added no new information and he was not the focus of this phase of our research projecvt. However, I did copy the following, which may provide more information about his New England involvement, in connection with the Narragansett lands:

"Proprietors Admitted of Narragansett Lands, by Humphrey Atherton or his Assigns," a list of names, "given by to Lord Culpeper, when here in N.E." As previously reported (in my January 9, 2011 report), there were no entries in online catalog (keyword, author, subject) re: New England Culpepers/Culpeppers (and spelling variants). I also searched for collections re: Lamb family and town of Roxbury, and other 17<sup>th</sup>-century New Englanders involved in shipping/trading activities of the Culpepers (per records found in previous phases or our research project), including John Winslow, John Stoughton, John Ford, Robert Gibbs, Capt. Edward Wood, Nicholas Page/Paige, and I found the following collections of possible interest. I went to the American Antiquarian Society to review them.

**Roxbury (Boston, Mass.) Papers, 1661-1846.** Mss. Misc. Boxes R. 1 folder (15 items). Includes bonds and receipts of John May (1663-1730), and later manuscripts. Reviewed, and found deeds and misc. documents, including: 17 Nov 1682 deed of John Alcock to Joshua Lamb, conveying Roxbury land. The later manuscripts include 1804 tax book, listing households in Roxbury. No Culpeper references found.

**Gibbs**, **Robert**, **ca.** 1634-1673 or **4**. **Business records**, 1659-1708. Mss. Misc. Boxes G. 4 folders (33 items) and Mss. Octavo Vols. G. 1 v. (108 leaves). Summary states: "Robert Gibbs (c. 1634-1674) was a Boston merchant. . . . These records note business transactions of Gibbs' general store for the period 1659 to 1708." *As reported in my research report of September 7*, 2011, John Culpeper was involved in a Boston lawsuit and trade dispute in 1662-1663 with a Robert Gibbs; possibly this was the same man.

I reviewed this collection and found papers from relevant time period, mostly account records indicating transactions of Robert Gibbs of Boston with William Gibbs of Barbados, indicating that Gibbs was involved in tobacco, sugar, rum and other Barbados trade, and mentioning Nicholas Page, John Ford and many others. E.g., 1667 trading voyage accounts including, re: "ye William," commanded by Edward Winslow," probably same ship that John Culpeper was part owner of in 1662-3 when captained

by Edward Wood. Documents in the folders appeared to be mostly accounts from trade; volume appeared to be account book for Gibbs' store, with small items sold on account to local people, women and men. 18 Jul 1671 account re: peas, wheat and Indian corn received from Caleb Lamb. Probate records at end of folders, indicating that Robert Gibbs was deceased by 1674.

No Culpeper references found.

I searched the Society's online catalog further in this phase of the project, and I also found these publications:

As previously reported (in my January 9, 2011 report), some of the Boston Public Library's collection is listed online, and I identified the Adlow Papers and Boston City Records as of possible interest. I went to the Boston Public Library and made a brief review of the finding aids to the Adlow Papers:

**Adlow (Elijah) Papers**. "10,000+ legal documents relating to Suffolk County and Massachusetts. The earliest records begin before the Revolution and include the Colonial Court Records, Supreme Judicial Court records, writs of attachment and execution, criminal complaints, [etc.]. The collection is partially cataloged."

12 vol. of finding aids, including several volumes of lists of writs of execution, and personal papers of various public officials (justices of the peace, etc.), organized by the judge or clerk who issued the documents. These volumes consist of lists of writs, by date and names of parties (but they are not indexed by name, and the dates are not all chronological). Also volumes re: coroner's reports, warnings out, justice of the peace recognizances, miscellaneous court orders, etc. Most for dates in 1800s, but I quickly reviewed re: documents for dates in 1700s.

No entries with Culpeper name found.

**Boston City Records**. "This material includes. . . Boston Town Meeting Minutes from 1634-1822, Boston Selectmen Meeting Minutes from 1701-1822, and early manuscript records of Brighton, Charlestown, Dorchester, Hyde Park and West Roxbury." Note: Sean Casey, Reference Librarian, believes that this collection includes some 17<sup>th</sup>-century records not in the published Report of the Record Commissioners series. The original Boston town meeting and selectmen minutes, however, are not indexed. Research would involve requesting volumes to review by year, and paging through the manuscripts. The collection also includes Boston tax records, beginning about the end of the Revolution.

I did not have time to review this collection.

Kittredge, about life of Robert Child, who had lived in early New England and then returned to live in England and Ireland from 1647 until his death in 1654. Sir Cheney Culpeper appears to have been a friend or acquaintance of Child's, whom he met after leaving New England. No indication that Culpeper had any New England connections. I did not copy this article.
